APPOINTMENT FOR THE INSPECTION OF TRANSPORTABLE PRESSURE EQUIPMENT IN GREAT BRITAIN – 2025

- 1. For the purposes of this letter-
 - 'CDG' means The Carriage of Dangerous Goods and Use of Transportable Pressure Equipment Regulations 2009 (as amended)
 - 'MSDG' means the Merchant Shipping (Carriage of Dangerous Goods and Harmful Substances) (Amendment) Regulations 2024
 - 'ADR' means the European Agreement concerning the international carriage of dangerous goods by road, 2025 edition
 - 'RID' means the Regulations concerning the international carriage of dangerous goods by rail, 2025 edition
 - 'IMDG' means the International Maritime Dangerous Goods Code, amendment 41-22 or 42-
- Acting on behalf of the competent authorities of Great Britain in accordance with regulation 29 of CDG and MSN 1852 (M), issued by the Maritime and Coastguard Agency in accordance with MSDG, the VCA Dangerous Goods Office hereby appoints Gaspack Services Ltd as:
 - An Appointed Body, No. 8539, for the approval of old pressure receptacles in accordance with CDG Regulation 14
- 3. The technical scope of this appointment is defined by the UKAS Schedule of Accreditation, Issue No 0016, dated 27 August 2024, specifically those parts identified by an asterisk (*) that are relevant to transportable pressure equipment in accordance with CDG.
- 4. This appointment does not extend to the inspection of equipment conforming to Chapters 6.7,

- 6.8, 6.9 or 6.10 of RID/ADR, whether or not filled and/or carried under pressure, the inspection of which is subject to separate appointment
- 5. This appointment does not confer any function of the competent authority to the appointee other than those identified herein and as set out in VCA guidance note GN-06
- 6. This appointment is subject to the terms and conditions which Gaspack Services Ltd has previously acknowledged and accepted.
- 7. This appointment expires 31 December 2025 unless earlier revoked.
